## **Chairman's Report – Mike Ratchford**

- Significant progress on North East River dredging
- Economic Development Strategic Plan – approved by Council; asked for additional information

## **Director's Report – Sandra Edwards**

- Funding approved for Economic Development Strategic Plan, working on RFP
  - Hope to share draft with EDC members and Council
- Request to Fill both vacant OED positions submitted to HR
- Ongoing one-on-one meetings with EDC members; received great feedback
  - Fielding interest in serving on Strategic Plan Steering Committee
- Partnering with County Chamber of Commerce:
  - Small Business Month Appreciation (May)
  - Cecil County Collective Meetings (get towns more engaged)
- Tourism:
  - Planning spring marketing
  - Part of Planning Committee for marketing grant promoting MD Horse Park System (part of MD Horse Industry Board)
  - Attending MD Tourism Development Board and MD Heritage Areas Authority meetings

- Winter Lights Cecil Nights – 5<sup>th</sup> year underway! Runs January-February, Check website for activities
- Chesapeake BayWay project planning, meeting, and workshop

***A Legislative Preview was presented by Hannah Allen, Director of Government Affairs, MD Chamber of Commerce***

- Today is opening day of 90-day legislature
- 2025 Legislative Priorities - Revenue:
  - **TAXES:**
    - State expecting ~ \$3B deficit for FY2026
    - Focus of legislature on raising additional revenue to balance State budget
    - MD showing slow growth and slow labor growth; private sector jobs lost
    - Not seen ton of growth in sales tax – one of State’s largest general fund revenue sources
    - Estimated revenues will only cover 80% of State’s current spending by 2030
    - Expect to see combined reporting on corporations, higher taxes on pass-through entities, expanding sales tax on services
    - Talk of personal income tax changes – increasing millionaires tax brackets
    - Adjustments/changes to blueprint to relieve State and local Board of Ed funding issues
    - Governor must introduce budget by Jan. 15th
  - **TRANSPORTATION FUNDING:**
    - Gap in Transportation Trust Fund
    - Reasons: Push for electric vehicle sales & drop in gas tax
    - Anticipate discussions on toll increases, vehicle miles traveled fees, retail delivery fees, expanding sales tax on services for transportation and related services
  - **CLIMATE FUNDING:**
    - MD has most ambitious climate goals in country
    - MDE report in 2023 – need to raise over \$1B/year to meet goals in report
    - May see legislative ideas introduced
    - MD - Can’t raise taxes for transportation, education, and climate – cost of living and **doing business already high**
  - **ENERGY:**
    - Piedmont Reliability Transmission Line Project
    - Push to electrify puts strain on grid – grid needs updates, more capacity needed especially to attract data center development in MD
    - Data center development good for local tax revenue
  - **DATA PRIVACY/ARTIFICIAL INTELLIGENCE:**
    - In 2024 passed Data Privacy law; law goes into effect Oct. 2025
    - Expect tweaks to legislation; align more with bills in other states
  - **CHILDCARE:**
    - Increasing availability remains priority (opening new facilities, expanding access to existing facilities)
    - Creates big workforce issue
- Session focus will be budget and revenue; hope to see considerations that grow economy and make people/businesses want to invest time & money in MD
