- County Executive presented his budget yesterday
- Week to go in MD legislative session – work to be done

## **Director's Report – Sandra Edwards**

- Staffing: Jake Herman, new Business Development Specialist

### **Introduction – Jake Herman**

- Third week with OED
- Grew up in Hershey, PA; attended Wilmington University
- Spent 1-1/2 yrs interning for USRC
- Excited for new opportunity with OED

## **Director's Report (Continued) – Sandra Edwards**

- Deputy Director, Rebecca Clark, starts on April 21, previously Queen Anne's County OED
- Enterprise Zone – confident program will remain intact
- Interviews with EDC Members – **Copy of Summary attached**
- Tourism:
  - Final reports from towns for Winter Lights Cecil Nights
  - Working on spring & summer marketing
  - Participated in Philadelphia, PA bus show followed by Travel & Adventure Expo in DC
  - Will be at Delmarva Sports Network Outdoor Expo in Harrington, DE later this month
- OED's budget being presented to Council on April 8, 4:30-6:30pm

- Governor and his cabinet here in Cecil couple weeks ago – toured Bainbridge, Rising Sun, and cabinet toured other locations around County – Cecil showed very well

### ***Administration Update – Dan Schneckenburger***

- County Executive announced at budget presentation that EZs restored but not definitized until General Assembly passes reconciled budget
  - Based on intelligence and proposed tax increases, we feel confident but need to wait for SINE DIE --
  - Will then send out press release to inform public
- Good to see OED fully staffed
- Want to get moving on strategic plan

### ***An update on Principio Business Park was presented by Gary Stewart, Jr., President, Stewart Properties***

- Cecil County special place for us
- Real estate group, building materials group, 3<sup>rd</sup> generation family looking to pass torch to 4<sup>th</sup> generation

### ***Principio Business Park Phase I***

- Rt. 40 and I-95 – Interchange project currently underway
- Several large tenants – Amazon, Restoration Hardware, Lidl, Medline, General Electric, Smithfield
- Next 5-10 years, focus will be Principio Phase II – will take place between CSX line and I-95
- Leverage interchange – truck traffic on/off I-95 and not utilizing County roads
- Current specs: 7.5MSF Built/Leased
- No Current Vacancy
- Current Assessed Value of Buildings \$595M, \$656 with Land

- 2024 Total Taxes Collected: \$8.4M; \$60.5M Cumulative
- 2024 Real Property: \$4.3M; \$1.3M Cumulative
- 2024 Personal Property: \$1.3M; \$12.8M Cumulative
- 2024 Income Taxes: \$2.8M; \$16.6M Cumulative

- Park employs ,200
- Avg. distribution salary \$62,656 (Over \$30/hr)
- Distribution salaries have increased 38% in past 10 yrs.
- Distribution salary growth 16% more than private jobs in Cecil Co.
- Current distribution avg. salary 14% higher than all private jobs in Cecil Co; 3.2% higher than avg. salary of all jobs in County (including Govt & private)

### ***Principio Business Park 3-5 Year Plan***

- Finish Phase I: 150,000 SF, 300,000 SF and (3) 100,000 SF buildings starting 2026
- Interchange Completion 2026/2027
- Belvidere Road Realignment Project 2027
- Belvidere Road Enhancement Project
- Begin Infrastructure and Entrance to Principio Phase II 2028
- Begin 1<sup>st</sup> Building, Negotiations ongoing with 1<sup>st</sup> client 2030 occupancy

### ***Principio Business Park Challenges***

- Desire to attract manufacturing, R&D and Data Center activity

- Most significant non-Government current limitations:
  - Power to attract large power consuming manufacturing and data
  - Water and Natural Gas to attract food and beverage, one of largest growing manufacturing sectors in Mid Atlantic market. (Last 3 projects were on average 1 MGD)
  - Labor pool for manufacturing jobs. While labor for distribution has been robust, unsure labor county could accommodate a 500-800 size manufacturing client
- Stewart Properties wants to be good partner with the County as well as companies that do business with Cecil County
- Considered great corporate citizen in County
- Look forward to more opportunities for more manufacturing, in turn, more opportunities for the County

- Mid semester; graduation in May

- Will be starting second utility training soon with Delmarva Power which pays for tuition and provides stipend

***Agriculture Update – Ariel Balog***

- Ag Education Days - 3–day-event end of April; gives every 7<sup>th</sup> grader in Cecil County public schools chance to learn about agriculture
  - Looking for volunteers and sponsors

***Workforce Update – Kim Justus, SWN***

- May 15 – Cecil County Job Fair
  - Employers interested in hiring should contact SWN to get a table
  - Graduating seniors from CCPS will be bused to job fair

***Christiana Care – Dr. Arsalan Sheikh***

- Dr. Sheikh has stepped down as campus president for Union Hospital – has gone back to original position, Chief Medical Officer
- Joan Pirrung, who was Chief Nursing Officer, will be Interim Campus President
- Hospital seeing surge of respiratory illnesses, flu virus in December-February; also bit more Covid
